



TEMPLATE FOR COMPSTAT

INSTRUCTIONS:

The goal of this template is to summarize the priority focus area in each district/unit in a way that can be measured and ultimately shared with internal and external partners to promote transparency within the department and with the community. This template is meant to serve as the crime plan for an extended period such as quarterly or bi-annually. The results of these crime plans should be examined at the end of each time period and district supervisors should be prepared to discuss what worked and what didn't work and why.¹

The template is designed to incorporate the three priorities of the CS360 model into a traditional CompStat:



Each district/unit supervisor must answer the following questions. These questions should be answered in collaboration with the district as a whole and should include input from all district personnel.

Using analysis of *historic* trends and *current* patterns, what is the highest priority crime problem(s) for the current reporting period in your district or area of responsibility? How did you determine this was the highest priority? (Ex: Stolen packages from front porches)
